The Defendant is accused by the Grand Jury of the County of Marion and the State of Oregon, by this indictment of the criminal offenses of:

- Count 01: ORS 164.055 THEFT IN THE FIRST DEGREE(C Felony)
- Count 02: ORS 164.055 THEFT IN THE FIRST DEGREE(C Felony)
- Count 03: ORS 163.205 CRIMINAL MISTREATMENT IN THE FIRST DEGREE(C Felony)
- Count 04: ORS 164.055 THEFT IN THE FIRST DEGREE(C Felony)
- Count 05: ORS 163.205 CRIMINAL MISTREATMENT IN THE FIRST DEGREE(C Felony)
- Count 06: ORS 164.057 AGGRAVATED THEFT IN THE FIRST DEGREE(B Felony)
- Count 07: ORS 163.205 CRIMINAL MISTREATMENT IN THE FIRST DEGREE(C Felony)
- Count 08: ORS 164.057 AGGRAVATED THEFT IN THE FIRST DEGREE(B Felony)
- Count 09: ORS 163.205 CRIMINAL MISTREATMENT IN THE FIRST DEGREE(C Felony)
- Count 10: ORS 164.055 THEFT IN THE FIRST DEGREE(C Felony)

committed as follows:

COUNT 01 The defendant, on or between January 1, 2015 to June 30, 2015, in Marion County, Oregon, did unlawfully and knowingly commit theft of money, of the value of \$1,000 or more, the property of another. The state further alleges that the property stolen had a value of \$1,000 or more

COUNT 02 In an act connected with, or constituting part of a scheme or plan common to Count 1, the defendant, on or between July 1, 2015 to December 31, 2015, in Marion County, Oregon, did unlawfully and knowingly commit theft of money, of the value of \$1000 or more, the property of another.

COUNT 03 As part of the same act or transaction as alleged in Count 2, the defendant, on or between July 1, 2015 to December 31, 2015, in Marion County, Oregon, having assumed the care, custody and responsibility of supervision of Dorothea Strandberg and EJ Strandberg, elderly persons, did unlawfully and intentionally or knowingly take for and appropriate to a use and purpose not in the due and lawful execution of the defendant's responsibility money or property belonging to Dorothea Strandberg and EJ Strandberg.

COUNT 04 In an act connected with, or constituting part of a scheme or plan common to Count 1, Count 2, and Count 3, the defendant, on or between January 1, 2016 to June 30, 2016, in Marion County, Oregon, did unlawfully and knowingly commit theft of money, of the value of \$1000 or more, the property of another. The state further alleges that the property stolen had a value of \$5,000 or more

COUNT 05 As part of the same act or transaction as alleged in Count 4, the defendant, on or between January 1, 2016 to June 30, 2016, in Marion County, Oregon, having assumed the care, custody and responsibility of the supervision of Dorothea Strandberg and EJ Strandberg, elderly persons, did unlawfully and intentionally or knowingly take for and appropriate to a use and purpose not in the due and lawful execution of the defendant's responsibility money or property belonging to Dorothea Strandberg and EJ Strandberg.

COUNT 06 In an act connected with, or constituting part of a scheme or plan common to Count 1, Count 2, Count 3, Count 4, and Count 5, the defendant, on or between July 1, 2016 to December 31, 2016, in Marion County, Oregon, did unlawfully and knowingly commit theft of money, of the total value of \$10,000 or more, the property of Dorothea Strandberg. The state further alleges that the victim of the theft was 65 years of age or older at the time of the commission of the offense.

COUNT 07 As part of the same act or transaction as alleged in Count 6, the defendant, on or between July 1, 2016 to December 31, 2016, in Marion County, Oregon, having assumed the care, custody and responsibility of the supervision of Dorothea Strandberg, an elderly person, did unlawfully and intentionally and knowingly take for and appropriate to a use and purpose not in the due and lawful execution of the defendant's responsibility money or property belonging to Dorothea Strandberg.

COUNT 08 In an act connected with, or constituting part of a scheme or plan common to Count 1, Count 2, Count 3, Count 4, Count 5, Count 6, and Count 7, the defendant, on or between January 1, 2017 to June 30, 2017, in Marion County, Oregon, did unlawfully and knowingly commit theft of money, of the total value of \$10,000 or more, the property of Dorothea Strandberg. The state further alleges that the victim of the theft was 65 years of age or older at the time of the commission of the offense. The state further alleges that the amount of loss caused by defendant was more than \$50,000.

COUNT 09 As part of the same act or transaction as alleged in Count 8, the defendant, on or between January 1, 2017 to June 30, 2017, in Marion County, Oregon, having assumed the care, custody and responsibility of the supervision of Dorothea Strandberg, an elderly person, did unlawfully and intentionally or knowingly take for and appropriate to a use and purpose not in the due and lawful execution of the defendant's responsibility money or property belonging to Dorothea Strandberg.

COUNT 10 In an act connected with, or constituting part of a scheme or plan common to Count 1, Count 2, Count 3, Count 4, Count 5, Count 6, Count 7, Count 8, and Count 9, the defendant, on or between July 1, 2017 to August 1, 2017, in Marion County, Oregon, did unlawfully and knowingly commit theft of money, of the value of \$1000 or more, the property of Dorothea Strandberg.

COUNT 11 As part of the same act or transaction as alleged in Count 10, the defendant, on or between July 1, 2017 to August 1, 2017, in Marion County, Oregon, having assumed the care, custody and responsibility of the supervision of Dorothea Strandberg, an elderly person, did unlawfully and intentionally or knowingly take for and appropriate to a use and purpose not in the due and lawful execution of the defendant's responsibility money or property belonging to Dorothea Strandberg.

Pursuant to ORS 131.582 and the adjoining statutes, it is further alleged that the property described below are instrumentalities of one or more of the crimes alleged in Counts 1-11, and therefore, that the following property is subject to forfeiture to the State of Oregon:




